9.4 Entries to be done -

9.5 The organizers may, with the consent of the Stewards, permit a change of car and/or class or driver on written application by the entrant, not later than one hour before the event, provided that either a change of car (and/or class) or driver is required, but not both (SPR104(vii)).

9.6 Every Entrant/Driver shall sign the declaration in terms of SPR 97/98.

9.7 No gate entrance fee, the race will be raced clockwise.

9.8 No unauthorized persons or unsupervised children under the age of 16 will be allowed in the pit area.

9.9 Only fully paid-up members will gain points for the championship. If a member is not fully paid up, he will have to enter as a non-member for the race and will not be able to score points for the Championship.

11. STARTS

- Qualifying for grid positions for Heat 1 will be timed by means of an approved timing system and starting positions will be determined by lap times recorded during official qualifying sessions. The kart recording the fastest time, will be in the number one position on the starting grid, with the remaining positions being filled in descending order of official practice times.
- The starting position for the second race will be determined by fastest lap times recorded in race one.
- The starting position of the third race will be determined by the fastest lap times recorded in race two.
- At the discretion of the Clerk of the Course, competitors who are not recorded on the grid may be positioned at the back of the starting grid.
- If the timing system fails in Qualifying, a lucky draw will determine the starting grid.
- If the timing system fails in the heats, the next starting grids will be the race ordered ended in the heat before.
- If the timing system fails in a heat, manual counting will be done.
- Flying starts to all classes.
- A senior kart will guide the flying start of the Bambino/Kidrok/Maxterino.

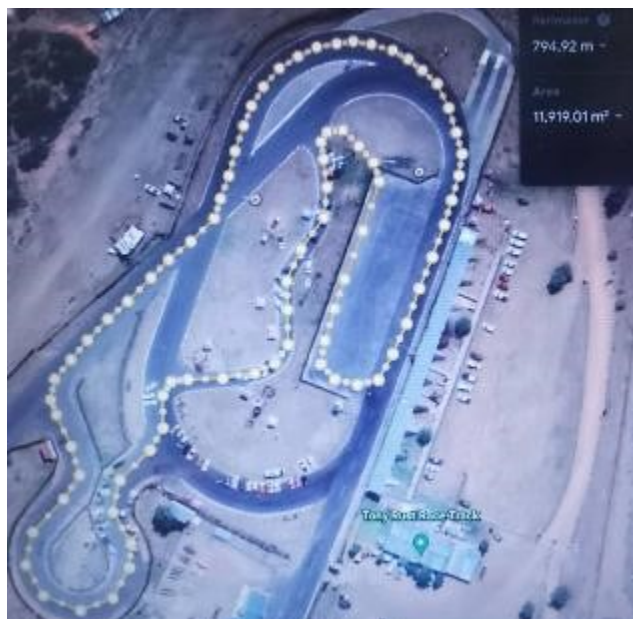

12. LINE UP IN PRE-RACE GRID

All karts must be lined up in the pre-race grid 5 minutes before the race starts. The entry to the pre-race grid will be closed 5 minutes before the race. If a competitor is not in time in the pre-race grid, he will get a DNS for the session, and may not start the session. Only the participant with his mechanic may enter the pre-race grid.

13. CIRCUIT LAYOUT AND DIRECTION



The layout will be raced anti-clockwise.

Bambinos/Kid Rok will race 8 laps per heat.

Maxterino, Micro Max, Mini Max, Jun Max, Sen Max, DD2, Kid Rok and Mini Rok will race 15 laps per heat. DD2 Masters will race 10 laps per heat.

- Please print the race entry, sign it, and **bring it along to the race, on race day.**
- Your entry will only be completed and valid once the hard copy of your entry has been handed in to the secretary on or before registration.
- All entrants MUST sign the Indemnity form that is attached to the pdf.
- Please sent the POP for race entry to carlaick777@gmail.com and attach it to the hard copy of the entry.

13.2 Registration on race day:

- Participant/Entrant must register themselves at the Secretary of the event.
- Please bring along your hard copies of your registration, signed, with your valid NMSF license for 2024.

14. SCRUTINEERING

Self-Scrutineering must be done online https://www.rokcup-na.com/wsurvey.php?survey_id=8440 and the Rotax on the Rotax Challenge App www.rmc-namibia.com before Friday 13h00, a day before race day. Karts will not be allowed to start if scrutineering was not done.

Weighing of karts will be done after each session. Karts must line up in Parc Ferme until weighting has been completed on your kart. **Your attention is brought to the NMSF Karting Bulletin 01/24.**

If your kart was not weighed, it will be deemed as DNQ in qualifying and for DNF on heats.

If the total weight of kart with driver, as per SSR 263, is under the limit, it will be deemed as DNQ in qualifying and for DNF on heats.

14.1 Scrutineering before Drivers Briefing:

All karts must pass the scrutineering on race day before drivers briefing. All karts must line up in the pre-race grid to go for scrutineering. Scrutineering will be done in the designated scrutineering area. Only the participant and 1 mechanic may enter the area.

14.2 Scrutineering throughout the heats:

Scrutineering can be done after each heat, at the discretion of the Scrutineer. Mechanics must have the necessary tools with them, 10mm spanner, 13mm Spanner, Spark Plug spanner, screwdrivers.

14.3 Scrutineering after heat 3:

All karts stay in parc ferme after heat 3. Only officials will be allowed in the parc ferme. It is at the discretion of the Scrutineer which karts will be inspected and it is his decision to what he wants to inspect.

16. PENALTIES AND EXCLUSIONS

Refer to part VIII of NMSF Handbook, Newest Edition Exceeding the track limit will be deemed as a penalizable action.

All competitors will only be allowed to exceed the track limits once during each heat unless it has been deemed as an accidental by the judges of fact and or CoC and there was no obvious gain by the competitor in question.

Exceeding the track limits may result in exclusion for said heat.

NOSE CONE(FRONT FAIRING) PENALTY

1.1 Nose cone(Front Fairing) penalties will be applied in accordance to SSR260.1 except for the Bambino class who will not be subject to nose cone(front fairing) penalties.

The Marshals, Timekeepers & Starter(s) will be deemed as judges of fact as per SR 19, SPR 165 or as allocated by the Clerk of the Course. An additional judge of fact might be appointed and strategically placed to check for exceeding the track limits. Judgement from a judge of fact will be deemed as correct and will be final.

CLUB CHAMPIONSHIP

Only a member of a specific club may earn points for that club, but any driver may win the day's trophy. Any driver racing without a transponder will not qualify for Club or National championship. The Club championship will be based on the National Championship as per the SPR's and SSR's of the NMSF.

POINT SCORING

1st Place 35

2nd Place 32

3rd Place 30

4th Place 29 and so on

Non finisher (less than 67% completed) receives five points less than the lowest points finisher. Zero points will apply for the heat exclusion. In the case of e.g., where only one competitor is participating in a class for the event, he will score 35 points for his first place. In the case a non-finisher has completed more than 66% of the race, he gets full points on the position he ended.

FUEL AND OIL

Competitors' attention is drawn to the 2024 NMSF Regulations for fuel and oil ratios. Controlled fuel where applicable will be 95 Octane unleaded fuel from Jan Jonker Service Station, 174 Jan Joker Road, Ausspannplatz.

The fuel used for this event will be '95 UNLEADED octane fuel.

Fuel testing/control will be imposed for all classes and will take place in Parc Ferme, both pre- and post-race.

Fuel testing will be continuous from Saturday morning the 13th April 2024.

No containers or funnels may be brought into the Fuel Control area.

Only the competitor him/herself or mechanic may be present in the Fuel testing/control area.

Drums for waste fuel will be provided by fuel control – please do not deposit waste fuel in the drains.

Bambino karts will be required to use fuel supplied by the organizers and leave their tanks in parc ferme between races.

It is compulsory for competitors to mix their fuel for this event as follows:

- a) 50:1 "Motul Kart Grand Prix 2T" for Micro Max, Mini Max, Junior Max, Senior Max, DD2 and DD2 Masters
- b) 30:1 "Motul Kart Grand Prix 2T" for Maxterino Class
- c) 25:1 "Motul Kart Grand Prix 2T" for Bambino Class (Supplied by organizers from morning qualifying – fuel tanks to be left in parc-ferme)

23. FRIDAY PRACTICE

All competitors are welcome to practice on Friday.

24. RENTING OF TIMING TRANSPONDERS

Timing transponders will be issued on Saturday morning by the race secretary or timekeeper. By renting a transponder from the organizers, competitors agree to pay the organizers N\$ 6500.00 inclusive of VAT in the event of damage or loss of a transponder. No further transponders will be issued before the outstanding transponder is returned or the levy paid.

Transponders must be mounted on the correct bracket on the front number bib.

It is not permitted to bolt or tape the transponder to the kart.

Please use the correct bracket.

25. TIME KEEPING

In the event of a malfunction of the timing system, hand scoring is applicable.

In the event of a malfunction of the timing system, the starting grid is determined by the finishing places of the previous heat.

In the event of a malfunction of the timing system at qualifying, starting position will be determined by way of draw.

26. TYRES:

Tyres are free but should you wish to score in the Rotax or ROK championships, the tyres as specified in the specific rules for each class must be used.

27. GENERAL

Littering, reckless driving and/or excessive noise and unsporting behavior by support crews might result in the following punitive measures to be instigated:

27.1 Team's exclusion from the final results

27.2 Reports to NMSF

27.3 Right to refuse entry in future events

28. GENERAL RACE DAY RULES:

- Appropriate racing wear.
- No sneakers.
- Neck braces are compulsory for all junior classes, recommended for all senior classes.
- 1st Gear in and out of pit area.
- Alcohol will not be tolerated inside the Pit Area
- No unauthorized people allowed in Pit Area
- All children under 16 under adult supervision
- Karts coming late and/or drivers that are not present during scrutineering will under no circumstances be allowed to race in any event.
- **All karts to be in pit area latest by 07:30AM**
- Races will be called out ONLY ONCE. Drivers not lining up immediately will not be allowed to race.

29. ALCOHOL CONSUMPTION:

A NO TOLERANCE policy is maintained with regard to alcohol consumption by anyone present in the pit area. This includes mechanics, crew, representatives, supporters, family, and friends. The competitor, or in the case of a minor, his/her representative, shall be responsible for the people in their pit area. If anyone is caught consuming alcohol or being under the influence of alcohol in the pit area, it may result in immediate disqualification of the rider/competitor. This will apply even if you have finished the event. There may be a breathalyzer present at the event and breath alcohol tests may be conducted at random fashion by the Chief Medical Officer at the discretion of the Clerk of the Course.

The Clerk of the Course may also have any individual rider, competitor, crew member and representative suspected of being under the influence of alcohol, tested by the CMO.

IF THE BREATH ALCOHOL TEST INDICATES ANY PRESENCE OF ALCOHOL, THE RIDER/COMPETITOR COULD BE EXCLUDED FROM THE RACE.



30. ANTI-DOPING CODE

The NMSF subscribes to the provisions of the World Anti-Doping Authority (WADA) and as such all competitors are bound by WADA rules and regulations, in respect of performance enhancing and use of banned substances during NMSF National Enduro events. Random drug testing may be demanded from time to time as directed by WADA, and all competitors must comply if so requested.

Any competitor taking any drug for therapeutic purposes, such as asthma, hay fever, ADD, etc. and which contains substances that are included on the WADA prohibited list, must obtain a Therapeutic Use Exemption, prior to entering any competition and submit with their entry at Official Documentation.
